Healthcare Professional Information Notice

Incyte Biosciences UK Ltd and its parent company Incyte Biosciences International Sàrl process your personal data in order to:

- Schedule meetings with you;
- Determine your interest in receiving information relating to Incyte products;
- Provide information relevant to your professional interests such as promotional, medical and educational information;
- Initiate or follow-up for clinical development programs; and/or
- Comply with voluntary or regulatory transparency reporting disclosures or other regulatory obligations.

We may process your data for other purposes. These purposes depend on our specific interactions with you, which could include:

- Adverse events/special situations/product complaints made by you, by one of your patients, or another person;
- Your potential or actual involvement as research investigator or research staff member;
- Your medical information requests; and/or
- Service/consulting agreements between you and us.
- Business Contacts at Institutions or Pharmacies

In certain instances you need to provide us with your personal data in order for Incyte to meet regulatory or legal obligations or where it is necessary for us to enter into a contract with you.

In all other instances, you are not obliged to provide us with any personal data.

Your personal data is shared by Incyte with:

- Other companies in the worldwide Incyte Group, wherever located (a list of all Incyte companies is available under: <http://www.incyte.com/contact-us/headquarters.aspx>);
- Third party consultants, service providers, partner companies contracted by or on behalf of Incyte or its affiliates, wherever located;
- Healthcare professional boards, authorities, wherever located;
- Government agencies, regulators, or public authorities, but only when they require us to. In some instances, these government agencies may make your personal data public in accordance with applicable laws or guidelines;
- Publicly online as part of voluntary transparency disclosures; and
- Where required by institutional policy or government entity, to your employer.

We transfer your personal data outside of the United Kingdom. Your personal data is transferred:

- To the European Union (EU), Switzerland, and Japan: The EU protects personal data process

within its boundaries under the General Data Protection Regulation (GDPR). Switzerland and Japan are considered as providing adequate data protection standards (for further details, see here https://commission.europa.eu/law/law-topic/data-protection/international-dimension-data-protection/adequacy-decisions_en). - To countries where data protection standards have not been determined to be adequate by the United Kingdom: these countries include the United States, India, and China. In these cases we will ensure that any recipients of your personal data are bound by contract to UK data protection standards.

For Incyte companies or its subsidiaries based outside the UK and EEA, Incyte has appointed Incyte Biosciences Distribution, B.V. as its legal representative.
